VMU Student Parliament activities:

- Elects the President of VMU SRC, the Board of VMU SRC, the Audition Commission of VMU SRC, the Chairman of the VMU Student Parliament;
- Adopts, supplements and amends the statutes, procedural rules and regulations of VMU SRC;
- Proposes, supplements, amends and approves resolutions, positions, other public statements of VMU SRC;
- Considers and approves the activity and financial report of VMU SRC, considers the report of the Audition Commission;

The most important documents are:

- Statute of VMU Student Representative Council
- VMU Student Representative Council Rules of Procedure

According to clause 3.1.6 of the Rules of Procedure of the VMU Student Representative Council, the VMU Student Parliament must have a meeting at least once a quarter of the year.

The president of the Student Representative Council, Ieva Vengrovskaja, proposed the dates of the next meetings.

## **VII. Problems of VMU Academic Departments.**

The problems of academic departments have been clarified:

- Unclear criteria for evaluating settlements;
- The exclusion of the campus (Akademija);
- The incompetence of the lecturer in lecturing;
- Cold in buildings;
- Fast pace of lecturers in freshman lectures;
- Lack of textbooks on foreign languages in libraries;
- Instruments for student use are unmatched;
- Poor communication between students, teachers and administration;
- Poor communication between doctoral students, their employment in institutes.

Activities of the Speaker of the Student Parliament:

- Organizes the work of the VMU Student Parliament;

Liepa Kalinaitė (ŠA): My goal as the Chairman of the Parliament would be to get more involved in the activities of the university, involve Vilnius students more and help parliamentarians solve the problems that have arisen.

Andrius Šmitas (Doctoral students): During your presentation, you mentioned that you are in your fourth year. Are you planning to graduate? Do you plan to enroll in a Master's program after graduation?

Monika Ražauskaitė (HMF): Yes, I plan to finish my studies and enroll in Master's studies.

**Decided: the election of the Chairman of the Parliament will be held in the format of electronic voting. Parliamentarians who did not attend the Parliament session will be able to get to know the candidates after reading their motivational letters.**
